Join the Credit Union

Just ask any member of our Credit Union how useful this has been when requiring a loan or just to save. It really is very easy to join, you decide how much you want to save each month and we will deduct it from your credit work.

There are certain times in the year when a loan is needed, for example:

- Your tax is due but you are short of funds.
- You want a holiday but don't have enough money.
- Just lately you had to have a conversion on your cab for the emissions.
- Were you caught out by not having the cash and take a loan from your Bank, Building Society or elsewhere? and pay large interest charges.

A typical loan from Radio Taxicabs (London) Credit Union Ltd is as follows:

£1,000 over 12 months will cost you £88.85 a month, total loan repayment is £1,066.20, interest payable is only £66.20, beat that if you can. In addition to this, all loans and savings are protected in the event of an untimely death. This normally costs a great deal more with other lenders.

There is a qualifying period of 3 months from the time of joining before a loan can be granted. You will then be eligible, should you wish, to apply for a loan and this can be up to 3 times the amount you have saved on a regular basis.

You do not have to take a loan if you don't want to. Just save an amount each month until you are ready to take out a Share Withdrawal to pay for whatever you want.
